Fund-raiser agrees that it shall be solely responsible for any and all safety and/or other provisions regarding the sale of these cards. Fund-raiser shall be solely responsible for any and all liability claims related to its participation in this program. Fund-raiser acknowledges and attests that it is a bona fide non-profit organization that is eligible and/or complies with the internal Revenue Service regulations under section 501c(3). Fund-raiser recognized that the Domino's Pizza offers on the cards are available at participating Domino's Pizza locations only, are not valid with any other offer or special, and only one offer may be redeemed per order. Fund-raiser will use its best efforts to accurately portray the offer when selling the card. This form must be filled out and signed again if additional cards are needed.
